**ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO ENTER INTO A COLLECTIVE BARGAINING AGREEMENT WITH AFSCME OHIO COUNCIL 8, LOCAL 914, AND DECLARING AN EMERGENCY.**


WHEREAS, the negotiating committee for the City of Norwood has reached a collective bargaining agreement with AFSCME Ohio Council 8, Local 914; now therefore

**BE IT ORDAINED** by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1.** The Safety-Service Director is hereby authorized to enter into a collective bargaining agreement for years 2016, 2017, and 2018 with AFSCME Ohio Council 8, Local 914. A copy of said Agreement is attached hereto and made a part hereof by reference.






