ORDINANCE AUTHORIZING THE SERVICE-SAFETY DIRECTOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT FOR THE PURCHASE OF 2,000 TONS, MORE OR LESS, OF SALT AT A BULK RATE, AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to purchase salt to be used to melt snow and ice on City streets and State highways within the City of Norwood; now therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. The Service-Safety Director is hereby authorized to advertise for bids and enter into a contract for the purchase of two thousand (2,000) tons, more or less, of salt at bulk rate for use on City streets and State highways within the City of Norwood, for the 2017-2018 winter season, in accordance with specifications on file in the office of the Service-Safety Director.

SECTION 2. The City Auditor is hereby authorized to draw, and the City Treasurer is authorized to pay warrants, for the foregoing purpose out of the STREET MAINTENANCE AND REPAIR FUND – 02 and the STATE HIGHWAY IMPROVEMENT FUND – 03.

SECTION 3. This ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to proceed forthwith to purchase and deliver salt in time for the freezing weather, at a market-competitive price.
